

CODE DESCRIPTION

CUSTOM DRIVEWAY GATE. VERTICAL WOOD PICKETS WITH "PICTURE FRAME" TOP. SEE MATERIALS BOOK FOR IMAGERY.

EXISTING IRON GATE RELOCATED HERE.

FLAGSTONE PAVERS.

EXISTING BRICK PAVERS RESET AS BORDER COURSE.

EXISTING BRICK SURFACING TO REMAIN.

PERGOLA SHADE STRUCTURE WITH 6X6 POSTS, 4X6 BEAMS, AND 2X2 TOP SLATS. SEE MATERIALS BOOK FOR IMAGERY. FASTENED TO EXISTING WOOD BEAMS ON HOUSE WITH SUPPORTS BUILT INTO STUCCO PILLARS ON DRIVEWAY SIDE.

REUSE EXISTING BRICK FROM NEAR DRIVEWAY TO USE IN THIS STRIP TO EXTEND PATIO.

ELECTRIC VEHICLE CHARGER STATION RELOCATED TO THIS NEW STUCCO PILLAR.

NEW 40" HEIGHT STUCCO PILLAR WITH POST BUILT-IN FOR OVERHEAD STRUCTURE.
